

Transfer of treasury shares in the context of stock option program

(the "Company") announces that, in implementation of its stock option program, which has been established by virtue of the resolutions dated 25/6/2015 and 6/7/2017 of the General Meeting of Shareholders and pursuant to resolutions of the Board of Directors dated 22/6/2017 and 10/7/2017, proceeded on 3/8/2017 to the transfer (through an over the counter transaction) of 887,454 common treasury shares to 76 beneficiaries / managers of the Company, following exercise of 906,930 of their relevant share options. The shares that have been transferred represent 0.29036% of the Company's paid up share capital.
