## PART C': Measures implemented by the Company to improve gender balanced representation on the Board of Directors

The Company applies a diversity policy with the aim of promoting a suitable level of differentiation in the BoD and a multi-collective team of members. Through putting together a broad range of qualifications and skills in selecting the BoD members, a variety of views and experiences is ensured, for the purpose of taking the right decisions. The policy includes the basic diversity criteria, which are applied by the Company in selecting BoD members and constitute essential priorities (diversity goals) of the Company, among which the criterion of adequate representation per gender.

Throughout the financial year 01.01.2024 - 31.12.2024, the Company was in compliance with the provisions of article 3 par. 1(b) of Law 4706/2020 and the respective requirements of the Suitability Policy regarding adequate representation per gender and, specifically, at least twenty five percent (25%) of the total BoD members, which percentage in case of fraction is rounded to the previous integer.

Taking into account the new provisions of Article 3A of Law 4706/2020, introduced by article 5 of Law 5178/2025, which establish increased requirements for balanced gender representation, the Company initially intends to conduct an evaluation of the effectiveness of the Board of Directors in accordance with the BoD Operation Regulation and its Evaluation Policy and Procedure. This evaluation coincides with the completion of one year of tenure of the current BoD, which was elected by the Annual General Meeting held on 27.06.2024. The BoD will carefully examine the results of the evaluation of its members and will ensure any necessary changes to its composition within the legally stipulated timeframe, with the aim of improving gender-balanced representation and safeguarding its collective suitability.
